Discuss the four factors that determine how useful ... The four factors determine the usefulness of information to a manager are: quality, timeliness, completeness, and relevance. Quality: Quality of information refers to how accurate and reliable the information is. An information is useful to the managers only if it has high quality (i.e. level or accuracy is high and information is reliable. 10 Four factors affect the computation of depreciation ...
